With a view to mitigating climate change, global efforts are being exerted in reducing greenhouse gases, which are the one of the main causes of climate change. Aligned with these efforts, Republic of Korea has set the Nationally Determined Contributions by 2030 and been seeking for a wide range of different ways to achieve the goal.

The forestry sector of Republic of Korea is also doing its best in order to cut down the greenhouse gas emissions not only from domestic forests but also from overseas ones. Since 2012, NIFoS has been initiatively conducting studies on reducing emissions in developing countries, by combating deforestation and forest degradation.
